Account setup for Big Sandy Lake, Sandy Pointe Lake, and Lake Allure.

The Whitehead Oil Company ACH Card is the fueling card required to pump at our Big Sandy Lake, Sandy Pointe Lake, and Lake Allure marinas. It is tied directly to your ACH payment authorization on file with Whitehead Oil Company — a standard credit card will not work at the pumps. To open your account, complete pages 2 and 3 and return this form by email, fax, or mail. Your card will arrive in approximately 10 business days after we receive your completed setup.

**AUTHORIZATION**

If a payment is declined, I authorize Whitehead Oil Company to make up to two additional collection attempts along with any applicable late charges and returned-payment fees. I may dispute any unauthorized debit by notifying my financial institution within the timeframe allowed under NACHA Operating Rules (60 calendar days for consumer accounts).

This authorization remains in effect until I provide written notice to Whitehead Oil Company (AR@whiteheadoil.com) in such time and manner as to allow the company and my bank a reasonable opportunity to act on it.
